

# SEIU LOCAL 1000 AND CALIFORNIA CORRECTIONAL HEALTH CARE SERVICES LVN TO RN PRE-APPRENTICESHIP PROGRAM INFORMATION

SEIU Local 1000, in partnership with California Correctional Health Care Services (CCHCS), is excited to announce a new application period for the Licensed Vocational Nurse (LVN) to Registered Nurse (RN) Pre-Apprenticeship Program. This program aims to assist current CCHCS LVNs, who meet specific criteria and who have completed the majority of prerequisite and general education coursework, successfully complete remaining science courses required to apply to the LVN to RN Apprenticeship program at San Joaquin Delta College (SJDC) or Riverside City College (RCC). Funding for this Pre-Apprenticeship is the result of SEIU Local 1000 research efforts to secure a California Apprenticeship Initiative (CAI) Grant, administered by Sacramento City College (SCC) that will cover tuition costs for Pre-Apprenticeship Approved Coursework.

# **Eligibility and Overview:**

In order to be eligible for consideration in the LVN-RN Pre-Apprenticeship program, applicants must:

- Have a current permanent, full time civil service status appointment in an LVN classification working for CCHCS and have passed the probationary period.
- Work for a participating institution at CCHCS (See Attachment A for a list of participating institutions).
- Be in good standing with CNE approval, have positive attendance, and have no corrective action within one year of the final filing date (May 28, 2024).

Applicants are expected to complete the pre-apprenticeship program within 2 years/6 academic terms. <u>At the conclusion of the 2 years/6 academic terms, pre-apprentices should meet science requirements necessary to apply to the targeted LVN to RN Apprenticeship Program.</u>

Lastly, applicants must be self-driven and possess a great deal of initiative. Not unlike enrolling in college as a traditional student, registration and continuation in this program depends on one's ability to independently and successfully complete application, registration, and other requirements throughout the duration of the program.

# **Steps: Coursework Registration/Program Application:**

- To be eligible for the Pre-Apprenticeship program, applicants must apply to one of the three colleges above and independently register for a <u>Pre-Apprenticeship approved course</u> for Fall 2024.<sup>1</sup> Registration is currently open at all three colleges.
- Applicants must also submit an online LVN to RN Pre-Apprenticeship Application which can be found at <a href="https://www.seiu1000.org/post/new-local-1000-lvn-rn-Pre-Apprenticeship-program">https://www.seiu1000.org/post/new-local-1000-lvn-rn-Pre-Apprenticeship-program</a>. The LVN to RN Pre-Apprenticeship application period is now open.

All applications must be received by 5:00 p.m. on Tuesday, May 28, 2024. For any issues submitting an application, please contact grow@seiu1000.org by 5:00 p.m. May 24, 2024.

- 3. The JAC will review LVN to RN Pre-Apprenticeship applications to determine whether minimum eligibility criteria are met and to evaluate each application based on the applicant's Statement of Interest. Applicants can expect to receive notice of their application status within six to eight weeks of the application deadline. Please also be advised that this is a competitive process; applicants who meet all minimum criteria may not be selected as a pre-apprentice due to space availability or other reasons.
- 4. Once selected, pre-apprentices will be provided with additional information and next steps. Pre-apprentice selection is tentative based on selected applicants providing documentation that they are registered or waitlisted in <u>Pre-Apprenticeship Approved Coursework</u> for Fall 2024, and potentially providing other transcript information.

# **Logistics and Support:**

Pre-apprentices may receive paid release time to support school attendance and academic success.

<sup>&</sup>lt;sup>1</sup> Note that the Pre-Apprenticeship program *is unable to secure/hold spaces in the Pre-Apprenticeship coursework* for any college. As such, it is the responsibility of the applicant to apply timely and successfully register for the Pre-Apprenticeship coursework.

When enrolling in pre-apprenticeship coursework, applicants are encouraged to select hybrid formats that include online lectures and in-person labs. In-person labs increase learning and retention of material which is helpful when taking nursing school admission exams, however, online labs can be accepted for admission.

To ensure successful outcomes in the Pre-Apprenticeship coursework, pre-apprentices may not enroll in more than one science course per semester.

<u>Pre-Apprenticeship funding covers tuition for Pre-Apprenticeship Approved Coursework only – this does not include other prerequisite coursework.</u> It is highly recommended that pre-apprentices meet with the financial aid officer at their targeted college to explore financial aid resources that may provide assistance with respect to materials cost or tuition for other coursework.

Required books may be loaned out to pre-apprentices when possible. However, pre-apprentices may need to pay for books directly.

# **Nursing School Entrance Exam:**

Upon successful completion of the Pre-Apprenticeship approved coursework and demonstration that academic requirements for admission to the targeted LVN to RN Apprenticeship Program have been met, pre-apprentices will be reimbursed registration fees for one attempt at taking the requisite Nursing School Entrance exam [Test of Essential Academic Skills (TEAS) or RCC Advanced Placement Test].
